This form is required of all international students admitted full-time to Northeastern University and who are currently enrolled at another U.S. school/college/university OR are in a period of Post-Completion Optional Practical Training (OPT) or Academic Training (AT) and are in F-1 or J-1 status. **Part I** must be completed by the student and **Part II** by the International Student Advisor at the school the student currently attends or has previously attended.

Please note:

- A student cannot be issued a Certificate of Eligibility (I-20 or DS-2019) from Northeastern until this form is completed and the transfer release date has passed.
- If a student needs to travel overseas and plans to return after the SEVIS release date, please be aware that he/she must be in possession of an I-20 or DS-2019 form issued by Northeastern and a valid F-1 visa
- International students must arrive on campus no later than the program start date indicated on the new I-20 or DS-2019 form and report in person to the ISSI during scheduled Immigration Clearance sessions. Only at that point will the student's transfer to Northeastern be activated in SEVIS by the ISSI.
