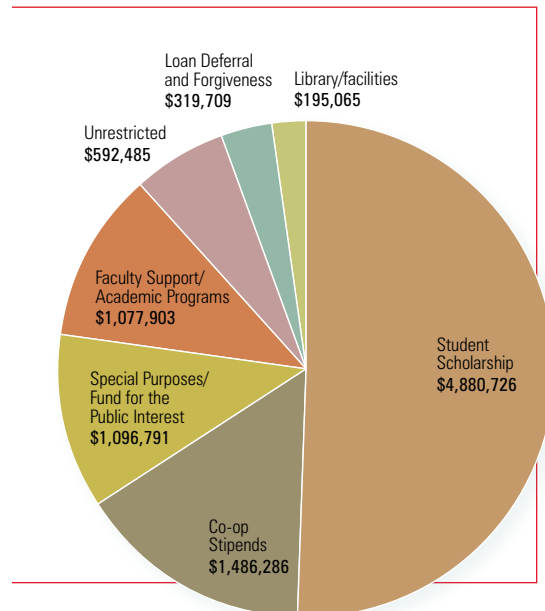


Endowed and Special Funds

The School of Law's total endowment provides needed revenue for our operating expenses and special purposes. As of June 30, 2010, the market value of our endowment totaled \$9,648,965. The endowment's funds are designated among six general support areas, as the "Market Value by Endowment Purpose" chart illustrates. This figure includes all endowed funds and monetary assets held by the university that are permanently restricted for use by the law school. It does not include funds held and managed externally by financial fiduciaries that are irrevocably designated for the School of Law's benefit.

The School of Law's endowment generated approximately \$476,800 in expendable income during fiscal year 2010 to support the general operation of the law school as well as specific scholarships and programs. Of all the endowed funds supporting our programs and operating budget, most support student scholarships. Gifts that establish endowed funds at the School of Law provide for the long-term financial stability of our institution. Endowed funds may be established to support scholarships, co-op stipends, the library or any program area. With a minimum gift commitment of \$50,000, which may be paid over five years, an endowed fund may be created and named in honor of the donor or as she or he directs. Alternatively, gifts of any size may be made to existing endowed funds.
