Benedetta Berti is the Earhart Doctoral fellow at the Fletcher School of Tufts University and a Neubauer Associate Research Fellow at the Institute for National Security Studies of Tel Aviv University. She also is an expert analyst for the Jamestown Foundation. She specializes in international security studies and Middle Eastern politics and was the Recipient of American Jewish Committee's Rosenthal Fellowship in International Relations to serve as Legislative Fellow in the office of Representative Adam B. Schiff.

Howard Cody is Professor of Political Science at the University of Maine and holds a joint appointment with its Canadian-American Center and serves as Director of its International Affairs program. His teaching and scholarship focuses primarily upon Canadian, Comparative, and European politics. His major research fields include parliamentary politics and core-periphery relations in regionally divided Westminster-model countries such as Canada, Australia, and the United Kingdom. Currently, he serves on the Executive Council of the Association for Canadian Studies in the United States and is Secretary of the regional Canadian Studies association, the Middle Atlantic and New England Council for Canadian Studies.

Stephen Collins is Assistant Professor of Political Science and International Affairs at Kennesaw State University. His research focuses on the practice of economic statecraft, especially as applied in the areas of democratization, nuclear proliferation, terrorism, and conflict resolution. Garrison Nelson is Professor of Political Science at the University of Vermont. His teaching and scholarship focuses upon American government, political leadership, and political parties. He is the author of more than one hundred articles and professional papers on the U.S. Congress and elections in Vermont. He is editor of *Committees in the U.S. Congress, 1947-1992*, co-editor of *Committees in the U.S. Congress, 1789- 1946*, and editor of the 30,000 committee assignment data base, 1947-1995 for WESTLAW and M.I.T. He also has served as President of the New England Political Science Association, as well as President and Executive Director of the Northeastern Political Science Association.

Luke Perry is Assistant Professor of Political Science at Southern Utah University. His expertise spans Comparative and American Politics with a focus on democratic development, Post-Soviet politics, the American presidency, and American political thought. His recent professional experiences include teaching in the Junior Statesmen of America summer program at Yale University, serving as a visiting scholar in Ukraine, and working with the Kellogg Foundation in the Rural People, Rural Policy Program.
