PREAWARD FINANCIAL COMMITMENT (PFC)
Policies and Procedures

1. **Obtaining a project Budget Number prior to the completion of the Award Process. Or, in multiple-year projects, obtaining authority to spend project funds prior to the receipt of the agency's award and associated cost share funds for the second or subsequent years of the project.**

Occasionally a delay occurs between the time a project has been approved/funded by a sponsoring agency and the time the award documents, signed by the authorized sponsor officials, are received by the University. During this interval, the University does not have formal authority to incur costs against the grant or contract; yet the timely start of a project, or the uninterrupted continuation of the project, may be crucial to its success. To bridge the gap, Northeastern University is instituting a procedure called the Preaward Financial Commitment (**PFC**).

The **PFC** makes it possible to provide an NU budget number where the charges incurred will be absorbed out of unrestricted accounts under the control of the person making the commitment in the event that there is an unfunded gap or that the outside funds fail to arrive at all. A **PFC** may cover the entire dollar amount budgeted for the project, or only a portion thereof. The person guaranteeing the **PFC** shall determine the amount sufficient to get the project started, or sufficient to allow the project to continue without interruption.

2. **PFC Procedures**

The principal investigator normally initiates the **PFC** process by completing the **PFC** form and obtaining the approval of the dean*. However, the principal investigator should first obtain reasonable assurance from the funding agency that the project will be funded, as well as an indication of the start date of the project and the amount of the expected award. The principal investigator should also prepare a budget, for presentation to the dean or other person guaranteeing the funds, for the amount being PFC'd.

Human and Animal Subjects in Research. If the project involves the use of human subjects (including the use of surveys or questionnaires) or animal subjects, approval of the protocols through the Institutional Compliance Division [ICD] (xt. 7570; 105 Dockser) must be obtained **prior** to the submission of the **PFC** to the Division of Sponsored Project Administration. No pre-award financial commitment will be permitted unless the protocols have been approved by ICD.

The **PFC form**, when signed by the person guaranteeing the dollar amount of the **PFC** is transmitted to the Division of Sponsored Project Administration (DSPA), together with any correspondence from the funding agency pertaining to the status of the award, *and a budget for the amount being PFC'd*. DSPA will then issue a budget number, or authorize the expenditure of funds, allowing the principal investigator to proceed with the project.

In the event that no award is made by the funding agency, any expenditures incurred pursuant to this **PFC** will be charged to the unrestricted fund account of the individual or unit guaranteeing the **PFC**.

* In some cases the preaward commitment may be made by the Department Head, Division Director, or Principal Investigator, singularly or jointly, if anyone of the parties has access to unrestricted funds.
